TERMS AND CONDITIONS FOR AUCTION OF SURPLUS EARTH FROM INDIRA MARKET, DEHRADUN

- 1. Location:** Indira Market Redevelopment Project, Indira Market, Dehradun.
- 2. Last Date & Time for submission of Bid Proposal :** 20 January, 2020 till 3:00 p.m. in MDDA office at Transport Nagar Dehradun
- 3. Tender Fee :** Rs. 5,000/- + GST (in form of Demand Draft and in favour of Secretary MDDA payable at Dehradun)
- 4. Earnest Money Deposit (EMD) :** Rs. 2,00,000/- (in form of Demand Draft/ FDR and in favour of Secretary MDDA payable at Dehradun)
- 5.** The approximate quantity of excavated earth (Soft Soil) is : 64,515 CuM
- 6.** The estimated quantity of earth is tentative and may vary to any extent on plus or minus side. Any such variation shall not entitle the applicant/firm for any claims on account of it, whatsoever.
- 7.** The quantity shall be measured in trucks for loose earth but shall not exceed the quantity of loose excavated earth at site, arrived at by increasing the volume of actual excavated earth by percentage of voids to be considered for loose earth as per CPWD specifications.
- 8.** The Reserved Price for the bid is Rs. **95,85,338.40/- (GST Extra)**, No bid shall be accepted lower than the reserve price.
- 9.** Highest rate bidder shall be considered as successful bidder.
- 10. Payment Condition :**
The Bidder has to pay the quoted amount as per schedule given below ó

S.No.	Instalment	Stages
1	1 st Instalment (20% of quoted amount)	Within 1 week of the acceptance of offer.
2	2 nd Instalment (20% of quoted amount)	Within 15 Days after the start of excavation.
3	3 rd Instalment (20% of quoted amount)	Within 1 Month 15 Days after the start of excavation.

4	4 th Instalment (20% of quoted amount)	Within 2 Month 15 Days after the start of excavation.
5	5 th Instalment (20% of quoted amount)	Within 3 Month 15 Days after the start of excavation.

Note :- In case bidder not submit the instalments on time MDDA may forfeit the EMD/ Deposited Amount, submitted by the bidder.

11. The rates shall be deemed to include all statutory taxes, cess and any other applicable statutory requirement (except GST). Bidder shall be responsible for the payment of all type of taxes, if any, as applicable and MDDA shall not be responsible.
12. Condition of Tax Collection at Sources (TCS) shall be mandatory as per the income tax act.
13. The provision of GST & Income Tax shall be applicable as per prevailing rules.
14. Bidder shall have to submit the following documents along with the bid document :
 - a) Bidder should have solvency of Rs. 20 lacs (Copy of original Solvency certificate to be submitted).
 - b) Copy of the GST registration,
 - c) PAN Card
 - d) Aadhaar Card
 - e) Earnest Money Deposit (EMD)
 - f) Tender Fee
15. **General Condition :**
 - a) The applicants/firm shall visit the site & MDDA before participating in bid process for the works and shall be deemed to be familiar with the site conditions.
 - b) Excavated Earth shall be allowed to be collected/transit simultaneously as the construction agency i.e. SAAMAG MDDA Realty Pvt. Ltd. Excavate the Earth from site. Bidder shall co-ordinate with MDDA and Construction Agency.
 - c) The pre-decided routes shall only be allowed for carriage of excavated earth. The applicant/firm shall apply for passes for movement of dumpers/trucks & equipments and provide the registration no. of the said vehicles.

- d) Any damage to the existing building/structure/fencing/wiring/ sewer lines/water lines/telephone cables/power cables etc. during carriage of earth or otherwise shall be rectified/made good by the applicant/firm.
- e) The disposal of earth shall include loading, unloading of excavated earth and shall be done by mechanical means only with sufficient number of such equipments including excavators, tipper/dumpers and any other men & machinery to be deployed to remove and dispose the earth in stipulated time.
- f) During the process of Transportation the Material should be covered by a thick covering sheet.
- g) The applicant/firm shall not unload/dump the excavated earth/ material on any Govt. Property / Private Property/ Parks/ River/ Nala / Khala etc. and the successful bidder shall be solely responsible after the collection of excavated earth from site.
- h) The applicant/firm shall be responsible for and comply all safety measures, labour regulations, traffic rules & timings, provisions etc.
- i) The bidder shall be liable for any mis-happening, damage at site or outside. MDDA shall not be responsible for that.
- j) Any type of material found at the site during the disposal it shall be a sole property of MDDA, bidder shall inform accordingly to MDDA and bidder shall not make any claim in any manner.
- k) In case MDDA is not satisfied with the performance of applicant/firm or progress of works, MDDA has the right to cancel the work order and forfeit the bid security. The applicant/firm shall not be entitled for any compensation from MDDA.
- l) The offer shall remain valid and open for acceptance for a period of 120 days from the date of submission of the bid as per the bid Documents or any extension thereto.
- m) The agency shall coordinate with existing contractor already engaged for excavation of earth and no claim, whatsoever, regarding re-handling of excavated earth shall be entertained.
- n) EMD will be released only after satisfactory completion of the assigned work on site.
- o) The bidders shall submit their complete detail along with Tender Fee, EMD, PAN Card, GST registration, Solvency Certificate, Aadhaar Card duly signed and stamped documents and price bid through e-tendering website i.e. www.uktenders.gov.in . Bidder shall submit

the Tender fee, EMD and Solvency Certificate in sealed envelope marked as **Proposal for Disposal of surplus earth from Indira Market, Dehradun** on or before **20 January, 2020** till **3:00 p.m.**

- 16.** For all legal matters relating to and arising out of above works, the jurisdiction shall be that of the courts at Dehradun only.
- 17.** The MDDA reserves the right to postpone or cancel the tender without showing any reason.
- 18.** Bidder shall comply to all the statutory provisions regarding the work for disposing of Excavated soil.
