प्राधिकरण कार्यालय के अल्पकालीन ई-निवदा सूचना पत्रांक 435/विद्युत कार्य कार्य/नि0सू0/2024-25, दिनांक 31.08.2024 के द्वारा सूचित किया गया था, जिसमे विधुतीकरण से सम्बन्धित 23 विकास कार्यो हेतु ऑन लाईन ई-निवदा के माध्यम से दिनांक 18.09.2024 को अपरान्ह 2:00 बजे तक uktenders.gov.in की वेबसाईट में आमंत्रित की गई थी। जिसे दिनांक 01.09.2024 को अमर उजाला एवं हिन्दुस्तान समाचार पत्र में प्रकाशित कराया गया। ई-निवदा सूचना के क्रम सं0 22 में उल्लेखित कार्य प्राधिकरण प्रांगण के अन्तर्गत डेकोरेटिव लाईट के कार्य की नियम एवं शर्तो में संशोधन करते हुए uktenders.gov.in की वेबसाईट पर उक्त टेन्डर में शुद्धि पत्र अपलोड किया जा रहा है जिसमे उल्लेखित नियम एवं शर्ते मान्य होंगी तथा पूर्व की शर्ते एवं नियम मान्य नहीं होंगी। विस्तृत विवरण टेन्डर वेबसाईट mddaonline.in पर उपलब्ध है।



# The Tenderer shall Provide Sufficient Documents/ Evidence for RGBW Building Illumination Work

#### **Pre-Qualification Criteria:**

- 1. OEM Shall be in business for more than 5 Years for manufacturing and supplying of luminaires, controls.
- 2. OEM shall have registered office in India and shall have PAN India sales and service support
- 3. OEM Shall be in business of Supply of Façade Lighting for more than 3 years and must have done successful installation of same.
- 4. OEM shall certify that the product supplied shall be made in India only. The luminaires offered in the project should have valid BIS certificate at the time of Tender. (mandatory)
- 5. OEM shall provide three years audited financial report of the company. OEM must have 50 Cr Average Turn over only in LED Lighting supply from Last 3 years
- 6. Luminaire, Drivers and DMX controller shall be from same company to avoid any integration issues
- 7. Luminaire manufacturer shall have in house NABL test lab for LM79 and other IS10322 testing
- 8. OEM/Bidder must have executed similar jobs in past and shall provide PO copies of work done in past
- 9. OEM/Bidder must have to upload / submit Simulation / Design and Product Technical Document.
- 10. The bidder also has to submit all the necessary technical catalogues, Test reports, Valid BIS Certificate, etc. The LM79 and IEC 60598 Test reports must be issued from a recognized NABL/International laboratory only Inhouse LM79 reports submitted must have Test certificate no. for Tracing/Tracking the authentication.
- 11. In case of non-submission of these documents & non- compliance of technical specifications, the bidder will not be qualified for the financial bid.
- 12. Bidder/OEM should not be Black listed from any of the Central Government/State Government/PSU. The bidder has to submit a self-certificate regarding the same.
- 13. Samples of the Light Fixture proposed should be submitted at time of technical evaluation, non-submitting of the same will lead to dis qualification of bid submitted.
- 14. Tender will be participated by OEM or its Authorized bidder. Bidder must submit the Authorization certificate from OEM to participate in the tender.
- 15. Bidder should have class "A" certification from chief electrical inspector (govt of uttarakhand) for Electric works for the current financial year.
- 16. Undertaking on Rs. 100 stamp paper for blacklisting/debarred from any govt undertaking/department/SEB/power sector etc.
- 17. Has valid ITR (last 3 years), GSTIN, TIN, PAN, registration certificate. Copy of all should be enclosed.
- 18. Manufacturing/Dealer ISO/BIS registration certificate. A copy of which should be enclosed.
- 19. Validity of the documents is for 90 days and if any case any documents found falsified tender will be canceled on its own.
- 20. The liability of the electrician and workers at site will be bidder only.

Payment terms: - The payment shall be made as per the following:

- 1. 70% amount of the work value shall be paid after supply, installation and commissioning of system at site.
- 2. Balance 30% of the contract value shall be treated as performance security and shall be paid against satisfactory performance and maintenance of the solar systems during 2 years warrantee and 2 year comprehensive AMC period. The amount shall be released against bank guarantee from any nationalized bank of equal amount for a period 24 months from the date of installation.
